2. In terms of KUSA regulations, any entry form(s) which lack the registration number of the dog(s) or contain the letters RAF or TAF (registration applied for or transfer applied for ) cannot be accepted. Please include your dog(s) microchip number on the entry form.
3. The requirement for entry into Working Class is at least: IPO1, CD "A" Test or BWT qualification. Proof of qualification to be supplied with entry form.
4. This is a **GRADING SHOW** – a typed Breed Critique will be available at the end of the show. No critiques will be posted. Entry numbers are to be collected on the day of the show.
5. All exhibitors/handlers are personally responsible for the control of their dog(s) at all times and shall be personally liable for any claims which may be made in respect of any injuries which may arise or be caused by their dog(s).
6. The RWBA reserves the right to appoint a different judge if necessary.
